The 75<sup>th</sup> Meeting of the Executive Committee of Gujarat Council of School Education was held at 16:00 hrs on 7<sup>th</sup> March 2024 for review and sanction of the activities for Samagra Shiksha under the Chairmanship of Dr. Vinod Rao, IAS, Secretary (Primary & Secondary Education), Education Department. The list of all the members present in the meeting is attached at Annexure-A.

Dr. Ratankanvar H. Gadhavicharan, IAS, State Project Director extended a warm welcome to the Chairman and all the members of the Executive Committee and started the proceedings of the meeting as per the agenda. The minutes of the meeting are as under:

# Agenda 1 & 2: To accord sanction to the Minutes of the 74th meeting of E.C. (02.08.2023)

The Minutes of the 74<sup>th</sup> Meeting of E.C. held on 02<sup>nd</sup> August 2023 along with the Action Taken Report were reviewed and unanimously approved, as there were no queries, suggestions or modifications on it.

# Agenda 5: To accord sanction for Vendors Selected for Printing and supply of Educational Material / TLM / Workbooks/ Booklets.

Tenders (15 Nos) for providing additional learning material and support to students of Government Primary and Secondary Schools under NIPUN Bharat Mission Learning Enhancement Program (LEP), PAT, Project Book, Educational Material / TLM/ Workbooks/ Booklets will be provided to Students of Grades 1 to 10 were published and successfully concluded.

Work Orders of total Rs.63,24,76,472.36/- has been given to the selected agencies against Estimated Cost of Rs. 84,64,15,020/- Printing and supply of Educational Material / TLM/ Workbooks/ Booklets after due tender process.

### Agenda 6: To accord sanction Musical instruments Grant for Elementary Schools.

Detailed guidelines were prepared by the experts for the procurement of musical instrument for Balvatika and Grades 1 and 2. Grant of ₹ 5,26,85,100 is proposed to be disbursed directly at the School-level to SMC for purchasing the musical instrument based on the enrolment of the Students and the guidelines.

The same was approved.

#### Agenda 7: To accord sanction Grant for Slate for Elementary Schools

Detailed guidelines were prepared for the procurement of Slates as TLM for Grades 1 & 2 Students at school-level. Accordingly, Grant of ₹ 6,79,35,315 is disbursed directly to SMC for purchasing the Slates based on the enrolment of the Students and the guidelines.

The same was approved.

After carrying out the tendering process on GeM, Maheshwari and Company, Chartered Accountant firm has been selected and appointed as "Statutory Auditors" for (1) World Bank-Asian Infrastructure Investment bank (AIIB) funded Gujarat Outcomes for Accelerated Learning (GOAL) Project, and (2) For Audit of Funds received under 100% State Government..

The same was approved.

The matter of selection of agency for upkeep & maintenance of the New Building of VSK through open tender process was discussed in detail. It was informed to the Committee that by selecting an agency through tendering route may financially cost much higher than the current cost

of upkeeping & maintenance of VSK being carried out through in-house manner. Hence, it was decided that to continue upkeeping and maintenance of the New VSK Building under existing in-house arrangements with increase of resources as required.

Also decided to take services from various Sakhi Mandal (*Swasahay* Group) under Misson Mangalam project for cleaning of the New VSK Building.

Above mentioned expenditure to be borne by respective HODs.

The same was approved.

Agenda 12: To accord sanction for multiple tender packages of repairing, new construction of various secondary schools, KGBV, DIETS, BRC Bhavan, classrooms in elementary school, Hostels, Repair & Restoration of Heritage Schools and other allied activities under Mission Schools of Excellence, GOI, GOG, NABARD.

Tendering Process for multiple repairing, New construction of various Secondary Schools, KGBV, DIETS, BRC Bhavan, Classrooms in Elementary Schools, Hostels, Repair & Restoration of Heritage School and other allied works under Mission Schools of Excellence, GOI, GOG, NABARD is required to be carried as per regular process.

In addition to this, for the purpose of reporting Upgradation of Child-friendly School Infrastructure under DLI-5 of the GOAL Project, it was instructed that all the Schools Upgradation work including Major and Minor Repairing, building Toilet Blocks, Boundary Walls etc. along with installation of Smart Classrooms and Computer Labs shall be considered as School Upgradation and reported against DLI-5 targets. The requirement of New or Additional Classrooms is dependent on Students enrolment year-on-year, hence the same shall not be considered under the definition of the School Upgradation for the reporting purposes of the GOAL project.

The same was Approved.

Agenda 13: To accord sanction for workorder to be released for various packages under Mission Schools of Excellence, GOI, GOG, PPM, PMVY, CSR and NABARD.

Tendering process for total 118 packages under Mission Schools of Excellence, GOI, GOG, PPM, PMVY, CSR and NABARD were concluded successfully. Work Order for amounting Rs. 450.30 Crores for the same are to be issued.

Convegenius Edu Solutions Pvt Limited with order valueRs.19,00,00,000/- with tax for 5 years.

After the Technical and Financial Evaluation of all received bids, 96 packages have been qualified. Out of all qualified packages,

- There were 75 packages (Sr no. 01 to 75) in which negotiated rate by the bidder is below or at par with the estimated rates, hence put up for approval to issue work orders.
- For remaining 21 packages, it was instructed to re-negotiate & convince the agencies to work at estimated rates. In case the agencies agree to work at the estimated rates, the work shall be awarded to the agencies accordingly, else it will be retendered.

The rates quoted by the bidders ranged from -11.91 % to 0.00 % of the estimated cost put up in the tender. Hence it is proposed to issue the total work order for the 362 packages for Rs. 1028.07 crore which is 2.21 % below the total estimated cost of tender Rs. 1051.30 crore.

For the remaining packages of qualified bidders, renegotiation shall be taken up and in case the qualified agencies agree to work at the estimated rates or below, the work shall be awarded to the agencies accordingly, else shall be retendered.

#### Agenda From the Chair-20:

To accord sanction to the extension of contract with M/s Deloitte Touche Tohmatsu India LLP for a period of three years for work awarded for Project Management Consultancy Services for implementation & monitoring of World Bank funded GOAL-SEEP project.

The work for Project Management Consultancy Services for implementation & monitoring of World Bank and AIIB funded GOAL-SEEP project has been awarded & contract agreement has been signed with M/s Deloitte Touche Tohmatsu India LLP for a period of three years starting from 12/07/2021 to 11/07/2024.

As per the terms of original RFP No. GCSE-SS /WB- GOAL/2021-22/PMC, dated 26/04/2021 and subsequently issued Work Order & Contract Agreement dated 12/07/2021, there is a provision to extend the Contract Period for 3 years on the same terms & conditions. With around 3 months left in the current Contract Period and looking to the ongoing implementation of activities and progress of achievements of GOAL project DLIs, it was decided to extend the contract period of M/s Deloitte Touche Tohmatsu India LLP for Project Management Consultancy Services for implementation & monitoring of GOAL-SEEP project for a further period of three (3) years starting from 12/07/2024 to 30/09/2027 (end of the GOAL Project as per World Bank Contract). A fresh Work Order for the same shall be issued.

Respected Chairman of the Executive Committee, Dr. Vinod Rao, IAS, concluded the meeting by expressing appreciation and gratitude to the entire team of the Gujarat Council for School Education – Samagra Shiksha. He commended the leadership of the State Project Director for the remarkable efforts in executing unprecedented initiatives such as Upgradation and Holistic Transformation of 20,000+ Schools under the Mission Schools of Excellence program. Additionally, their adept management of staff recruitment process through the Gyan Sahayak policy, and successful implementation of the Gyan Shakti Residential Schools of Excellence programs, including adherence to SOPs, selection of project partners, and distribution of school vouchers, were acknowledged as commendable achievements over the past few years. The entire team was encouraged to maintain this momentum to enhance schooling and learning opportunities for students in the State.
